

No waiting period for pediatric dental benefits.

Dental visits for children are "two" important!

According to the American Academy of Pediatric Dentistry, more than 50 percent of children will be affected by tooth decay before age five. To keep their teeth healthy, your child should visit the dentist for a cleaning TWO times a year, and they should brush and floss TWO times a day for TWO whole minutes!

Rates are determined per individual. The premium rate for family coverage is based on the number of individuals in the family that enroll in coverage and the age of each family member. If you have children covered under the plan, you will only pay premium for up to three children under the age of 19.
