## The Value of Blue

You have a one-time opportunity\*\*\* to:

1. Transfer to an open Plan 65 option of your choice if you are coming from a BlueCHIP for Medicare plan effective October 1, 2013 or later with no lapses in coverage.
2. Transfer from Plan Select F to Plan F or vice versa.

## Convenience and savings: Electronic funds transfer (EFT) option

Select the EFT payment option on your Plan 65 application and save \$2/month.

## Improve your plan: Add Blue Cross Dental coverage and/or a Prescription Drug Plan

Rates shown apply to members enrolling in Plan 65 within six months of becoming eligible for Medicare Part B. Certain changes in your circumstances can qualify you to enroll in Plan 65 as well. The network is subject to change at any time.*
